SUSTAINABLE LIVELIHOOD PROGRAM ACCOMPLISHMENT FOR CY 2013

For CY 2013, the Sustainable Livelihood Program served 191,948 poor families from January to December 2013. Ninety percent (90%) of the total accomplishment for CY 2013 or 171,986 families are Pantawid Pamilya while the remaining 10% or 19,962 are Non-Pantawid families.

178,190 families or 90% were served under the Micro-enterprise Development Track, while 13,758 or 10% were served under the Employment Facilitation Track. Under the Micro-enterprise Development Track, the families were provided with financial capital assistance either by DSWD through the Self-Employment Assistance-Kaunlaran (SEA-K) modality or by other external funders such as Micro-Finance Institutions (MFIs), National Government Agencies (NGAs) and Local Government Units (LGUs) for them to engage in resource-based and market-oriented income generating projects. Some families, who opted for non-financial assistance, were provided with basic entrepreneurial skills training (e.g. micro-entrepreneurship, business plan preparation, etc.) to help them manage their micro-enterprises and ensure its sustainability. Other families were provided with equipment and other start-up materials by partner NGAs and LGUs for them to engage in profitable and productive activities. Table 1 shows the disaggregation of the families served under Track 1.

Majority of the families under Track 1 were served through the SEA-K Modality and were provided with a total **PhP 704,880,765.00** worth of **capital seed fund**. The attached SLP Accomplishment Report for January to December 2013 shows the total amount of capital seed fund released by each region.

On the other hand, the DSWD in collaboration with NGAs such as the Department of Public Works and Highways (DPWH), Department of Agriculture (DA), Department of Environment and Natural Resources (DENR) and Technical Education and Skills Development Authority (TESDA) and private employers were able to provide jobs to 13,758 families in 2013. Table 2 shows the number of families employed by each partner agency/institution.
