Sealed bids shall be accompanied by a **bidder's bond** in the form of cash, cashier's check or manager's check in the amount equivalent to at least **ten percent (10%)** of the Total Bid Offer, and shall be submitted to PDAC Secretariat not later than **7:30 a.m. of June 18, 2019**. Opening and deliberation of sealed bids shall be at **8:00 a.m.** of the same date, at the NCTSU Room, 4th Floor, Magiliw Bldg., DSWD-Central Office.

The DSWD-Central Office hereby reserves the right to reject any or all bids, to waive any formality therein, or to accept such bid/s that may be considered most advantageous to the government.

Let copies of this Invitation to Bid be posted to three (3) conspicuous areas within the Department and be advertised in the DSWD website for 5 consecutive days to invite qualified bidders.
