SUBJECT: AMENDMENT TO ADMINISTRATIVE ORDER (AO) NO. 16, SERIES OF 2019

In order to ensure consistency in the rules to be followed in the approval of (1) Requests for Procurement of Goods, Civil Works and Consulting Services and (2) Proposals for Regular Program, Project and Activity by Offices/Bureaus/Services/Units (OBSUs), the pertinent provisions of Administrative Order No. 16, series of 2019 is hereby amended to be read as follows:
